Whereas, upon intimation of the above manipulation of land records, a report was lodged to Superintendent of Police, Imphal West by the Survey & Settlement Officer, DSLR, Manipur, vide letter No. 100/5/MLR/DSLR-2022 dated 25th August, 2022, for initiating an investigation. Thereafter, an FIR No 170(8)2022 LPS u/s 465/466/468/417/420/120-B IPC was taken up at the Lamphel Police station, report of which is still awaited.
