No.10/180/2021-REV(U1CL)/0436 : It is hereby notified for information of the general public and concerned affected villagers in particular that NOTIFICATION vide No. S.O. 3418(E) dated 27.07.2022 has been issued by the Ministry of Road Transport and Highways, New Delhi, published in Gazette of India, Extraordinary Gazette No. 3256 New Delhi, Wednesday, 27 July, 2022/SHRAVANA 5, 1944, that in exercise of the sub-section (1) of section 3D of the National Highways Act, 1956, the Central Government declares that the lands specified in the SCHEDULE annexed thereto should be acquired for building (widening two lane), maintenance, management and operation of NH-202 on the stretch of land from Km. 0.00 to Km 15.00 in the Ukhrul district, Manipur.

Further, in pursuance of sub-section (2) of section 3D of the said Act, the Central Government declares that on publication of this notification the land specified in the SCHEDULE shall vest absolutely in the Central Government and it shall be free from all encumbrances.

New Delhi, the 27th July, 2022

S.O. 3418(E).- Whereas by the notification of the Government of India in the Ministry of Road Transport and Highways, published in the Gazette of India, Extraordinary, Part II, Section 3, Sub-section (ii) issued under sub-section (1) of section 3A of the National Highway Act, 1956 (48 of 1956) (hereinafter referred to as the said Act), the Central Government declared its intention to acquire the land specified in the Schedule annexed to the said notification for building (widening/four-laning, etc.), maintenance, management and operation of NH202 on the stretch of land from Km 0 to Km 15 (DC Office, Ukhrul, Manipur, Pin-795142) in the district of UKHRUL in the state of MANIPUR;

And whereas the substance of the said notification has been published in "The Sangai Express" and "Hueiyen Lanpaao" both dated 12.02.2022; under sub-section (3) of section 3A of the said Act;

And whereas objections have been received and the same have been considered and disallowed by the competent Authority;

And whereas, in pursuance of sub-section (1) of section 3D of the said Act, the Competent Authority has submitted its report to the Central Government;

Now, therefore, upon receipt of the said report of the Competent Authority and in exercise of the powers conferred by the sub-section (1) of section 3D of the said Act, the Central Government hereby declares that the land specified in the said Schedule should be acquired for the aforesaid purpose;

And further, in pursuance of sub-section (2) of section 3D of the said Act, the Central Government hereby declares that on publication of this notification in the Official Gazette, the land specified in the said Schedule shall vest absolutely in the Central Government, free from all encumbrances.
