No. 12/PMS-FORMS/2012-TA&H: It is hereby to inform all concerned that, Notification for online submission of application for availing ST Pre & Post – Matric scholarship for the year 2024-2025, notified vide Notification No. **12/PMS-FORMS/2022-TA&H dated 03.09.2024**, is extended further up to **15.01.2025** as per the schedule provided below:

2. The intending ST students shall submit applications for the year 2024-25 on online mode only through National Scholarship Portal (NSP 2.0) in the website www.scholarships.gov.in

3. The Last date of online submission details will now be as given below:

4. Further, it is informed to all the student desiring to avail Hosteller benefit under the scheme, the guidelines provided at Note 3, para 3.4.2. of Post Matric Scholarship issued by Ministry of Tribal Affairs, Govt. of India needs to be ensured while submitting application through NSP, which is reproduced as given below:

"Normally the term 'Hostel' is applicable to be common residential building and a common mess for the students run under the supervision of the educational institution authorities. In case the college authorities are unable to provide accommodation in the college Hostel, an approved place of residence can also be treated as Hostel for the purpose of this scheme. The place will be approved by the Head of Institution after due inspection and keeping in view the rules and regulations laid down by the University, if any. In such case, a certificate to the effect that the student is residing in an approved place of residence as he is unable to get accommodation in the college hostel should be furnished by the Head of the Institution".

ii. Applications submitted without certification by the Head of Institutions as per the above will be summarily rejected.

5. All student applicants are informed to use their unique mobile no., email ID, Log in ID and unique password for submission of application over NSP and maintain proper records of such credentials for future reference.

6. All Institutes, both Central/State Govt. which are fully funded by the govt. and students who are pursuing their studies Free of Cost are informed not to apply for the Pre-& Post matric ST Scholarship e.g: EMRS, JNVs etc. In case, such applications are received from such Institutes, it shall be summarily rejected and penal action will be initiated against the institute's head.

7. All Institutes shall ensure verification and submission of application for the above scholarship as per the no. of students enrolled in the AISHE/UDISE database mandatorily.

8. The Notification is issued for General Information and Strict Compliance by the respective Institute heads as well as Institute Nodal Officers.

9. Therefore, all Students/Principals/HODs/DNOs of various institutes located in Manipur and outside the State are directed to complete their application and verification process well on time before the expiry of the extended dateline.
