No. MU/24-1/DACE/Adm/Aca: Online applications are invited from **candidates belonging to Persons with Disabilities (PWD)** only for admission to the following programs/courses offered by Dr. Ambedkar Centre of Excellence, Manipur University, under the Free Coaching Component of "Scheme of Scholarships for Students with Disabilities" of the Department of Empowerment of Persons with Disabilities (Divyangjan), Ministry of Social Justice and Empowerment, Government of India:

Courses Offered :

- UPSC/MPSC Civil Services Examination (Preliminary and Mains)
- Banking/Insurance/PSU/SSC/RRB(Group A and B examinations)

Course Details and Intake Capacity:

**The course fee will be released by Dr. Ambedkar Foundation, Department of Social Justice and Empowerment, Ministry of Social Justice and Empowerment, Government of India, in two instalments of 50% each through DBT in the candidate's Aadhar-enabled bank account. The candidate shall be required to remit the fee to the University immediately and in any case not exceeding 15 days on receipt of the course fee.*

Stipend: All the selected candidates will get a stipend/maintenance allowance of Rs. 4000/- per month along with a disability allowance of Rs.2000/-per month for the duration of the course. Additionally, a one time book allowance of Rs. 5000/- per course will be provided.

Reservation: There will be 30% reservation of seats for female candidates.

Eligibility Criteria:

1. The scheme is only for Indian nationals (preferable to Domicile of Manipur).
2. The candidate must hold a graduate degree from a recognised institution or possess an equivalent qualification or must be in the final semester of graduation.
3. Age limit:(21–42 years).
4. The Scheme is open to students with benchmark disabilities i.e., 40% or more disability as defined in 'Rights of Persons with Disabilities Act, 2016' and having a valid certificate of disability issued by the competent authority as prescribed under Rules.
5. Unique Disability ID (UDID) number with disability certificate is mandatory.
6. Only candidates with benchmark disabilities, having total family income from all sources of Rs.8.00 lakh or less per annum, will be eligible for benefits under the Scheme.
7. Benefits under the Scheme can be availed by a particular candidate not more than once.
8. Not more than two children with disabilities of the same parents will be entitled to receive benefits of the Scheme. In case the second child is a twin, the benefits under the Scheme will be admissible to the twin.
9. The candidate shall be precluded from availing benefits under any other coaching scheme of the Centre or State government and will be required to provide a declaration to this effect.

Selection Procedure: Through an Admission Test conducted by the DACE, MU, as per merit basis.

- **UPSC/MPSC CSE:** The Admission Test will comprise of 100 MCQs with each question carrying 2 marks. The syllabus of the Admission Test will be similar to the syllabus of UPSC CSE Preliminary General Studies Paper-I. The questions will be of NCERT level. **Duration: 2 hours.**
- **Banking/Insurance/PSU/SSC/RRB (Group A and B examinations):** The Entrance Test will comprise of 80 MCQs with each question carrying 2 marks. The syllabus of the Entrance Test will include: Quantitative Aptitude (20 Qs), General Mental Ability (20 Qs), General English (20 Qs), and General Awareness (20 Qs). **Duration: 90 minutes.**

Documents to be submitted/uploaded with the application form: One colour passport size photo, Oneself-attested copy of age proof certificate, Oneself-attested copy of mark sheets and certificates from matriculation up to highest degree, Oneself-attested copy of certificate of disability (along with UDID number), Oneself-attested copy of income certificate (not older than one year from the last date of application form submission), Oneself-attested copy of Aadhaar Card, Details of Aadhaar-enabled bank account
