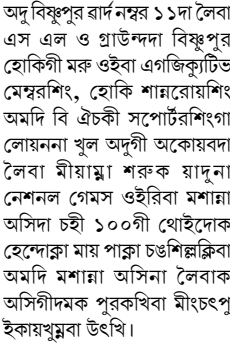

No. 1/8/2018-MHR(Law): This is for information of all interested persons in connection with filling up the following posts in Manipur Human Rights Commission, for furnishing their applications along with required information as given below:

(1) Post:	(1) Chairperson of Manipur Human Rights Commission (2) 01(One) Member of Manipur Human Rights Commission [S.21(2)(b)]
(2) Number	(1) Chairperson - 01 (2) Member [S.21(2)(b)] - 01
(3) Terms of appointment:	03(three) years from the date of entering upon his /her Office and shall be eligible for re-appointment for another term of 03(three) years, provided that no member shall hold office after attaining age of 70 years (Section 24(2) of the Protection of Human Rights Act, 1993) (Ref.: Conditions under Section 24 of PHR Act are binding)
(4) Eligibility:	(a) Chairperson: a person who has been a Chief Justice or a Judge of a High Court; (b) Member: a person who is, or has been, a Judge of a High Court or District Judge in the State with a minimum of seven years experience as District Judge.
(5) Language requirement:	Working knowledge of English and Manipuri language.
(6) Salaries & Allowances:	Salaries & Allowances will be governed by the Manipur Human Rights Commission (Salaries and Allowances and other Terms & Conditions of service of the Chairperson & Members) Rules, 2004 as amended from time to time.
(7) Age limit:	Age of applicant shall be below 70 years. (preferably not above 69 years of age on the date of submission of application)

Regarding the above, the relevant provisions under the Protection of Human Rights Act, 1993 will be applicable.

- Required Information / documents:
 - (1) Application with full bio-data
 - (2) Scanned passport size photograph recently taken
 - (3) Scanned Aadhar card, up and down
 - (4) Copies of testimonials (scanned copies) (if any)
- Interested persons may submit their application along with their bio-data to the Commissioner (Law & Legislative Affairs), Govt. of Manipur in online mode only via e-mail to secy.law-mn@gov.in by 05-00 pm of 08th December, 2025. No physical/hard copy of application will be accepted.
- It is to inform that, the persons who had applied for the posts of Chairperson and member following Notification dated 8/10/2024, may not submit fresh application. Their candidature will be considered subject to fulfilment of conditions, under the Act.
